

Key Features of Deen Dayal Swasthya Seva Yojana (DDSSY)

Procedure to Apply Online

1. Register yourself on goaonline.gov.in and login.
2. Fill details of the eligible person / head of the family
3. Add the member details.
4. Add residence proof details. Note you will need to attach residence proof of minimum 5 years without which your application will not be considered. All the attached documents should be self attested.
5. In case you need to avail concession on the registration fees, Please provide Caste / Income details.
6. Each member aadhaar card to be attached. In case of minor kindly attach birth certificate if aadhaar card is not available.
7. Registration Fees 1)For family of 3 or less members, Rs.200/- 2)For family of 4 and above members, Rs.300/- 3)Concession of 50% will be considered subject to submission of appropriate documents towards OBC of non creamy layer, SC/ST & differently abled eligible person.
8. Eligibility 1) Any person residing in the State of Goa for five years or more is declared eligible person under DDSSY. Family of eligible person is defined as his/her Spouse and Unmarried children and Dependent Parent(s) / In-Laws (Incase eligible person is female). This Family unit cannot be split. 2) Central/State Government employees and their families covered under government medical reimbursement are not eligible under DDSSY.
9. Pay relevant Fees by clicking proceed to pay.
10. After payment note down the Acknowledgement No for tracking purpose.
11. DDSSY e-card shall be made available for download only on verification and approval of your application by the respective office.
12. Please note on approval collect your ddssy card within 30 days from respective office selected during application entry .
13. Communication will be sent to the registered Mobile Number.

Procedure to Apply Offline

1. Visit Any nearby centres below.
2. Fill details of the eligible person / head of the family
3. Add the member details.
4. Submit residence proof details. Note you will need to attach residence proof of minimum 5 years without which your application will not be considered. All the attached documents should be self attested.
5. In case you need to avail concession on the registration fees, Please provide Caste / Income details.
6. Each member aadhaar card to be attached. In case of minor kindly attach birth certificate if aadhaar card is not available.
7. Registration Fees 1)For family of 3 or less members, Rs.200/- 2)For family of 4 and above members, Rs.300/- 3)Concession of 50% will be considered subject to submission of appropriate documents towards OBC of non creamy layer, SC/ST & differently abled eligible person.

9. Pay relevant Fees at the respective center payment booth.
10. Please note on approval collect your ddssy card centre when told by the incharge from respective office .

Documents required

- 1.All uploaded documents should be self attested.
- 2.Aadhaar Card / Enrollment Acknowledgement Slip of every family member above age of 5 years.(Compulsory)
- 3.Residence Proof of eligible person: Passport|Residence Certificate|Voter ID|Driving License |Aadhaar Card issued minimum 5 years ago in Goa. The issue date should be visible on the attached residence proof.
- 4.Ration Card to define a family.

In case ration card is not available enclose all the below mentioned documents:

- 1.For spouse - Marriage Certificate |Birth Certificate of Child | Passport | Voter Id | (with spouse name mentioned on it)
- 2.For dependent child - Birth / School leaving certificate.
3. For dependent parents - Declaration stating Parent(s) / In-Laws are not employed.
 - a) For OBC of non creamy layer - Caste certificate issued by Deputy Collector along with Income Certificate issued by Deputy Collector/Mamlatdar showing income less than 6 lakhs per annum
 - b) For SC/ST - Caste Certificate issued by Directorate of Tribal Welfare/Deputy Collector.
 - c) For Differently abled eligible person - Disability certificate issued by Medical Board./ Disability Identity Card issued by Directorate of Social Welfare
